- A \$200 non-refundable deposit is required to “Save the Date”
- The deposit will go towards your trial run service.
- A trial run is required for the services of the bride.
- The remaining balance of services is due 7 days prior to the wedding day.
- Cancellations or adjustments of any services must be made 14 days prior to the wedding day. If cancellations or adjustments of services are made with less than 14 days notice, the full service fee will be charged.
- If Brit Tarr is unable to perform the agreed services for any unforeseeable reason or unavoidable situation, due to circumstances or any cause beyond her control, any and all payments shall be returned to the client with the understanding that there will be no further liability with respect to this contract.
- A travel fee will be charged for all on location services, per stylist.
- Gratuity is not included in service prices and is at your discretion.
- The bride assumes responsibility of payment to the stylist for all members of the bridal party receiving services. One payment is to be made by the bride for total services rendered after deposit.
